#### **Acknowledgement of Country**

Youth Action acknowledges the Traditional Custodians of Country throughout Australia and understands that sovereignty was never ceded. Our office is located upon the land of the Gadigal people and we recognise their traditional and ongoing Custodianship and pay our respects to Elders past, present and emerging.



It gives me great pleasure to set out the Strategic Plan for Youth Action for 2021-2024 (the Plan). It is a privilege for the team and I to build upon the great work that Youth Action has done for decades. As has always been the case for Youth Action, it was important that defining how we hold ourselves accountable, how we will work, and how we will prioritise was done in partnership with the youth sector (the Sector) and young people.

We have had the honour of hearing from our Members and from those who work with young people every day. Listening to their lived experiences and acting on their input and advice ensures that we are on the path to realising the rights of young people in NSW. We gathered input from the Sector through our monthly Sector meetings, and we greatly appreciate the responses to our Plan survey from our diverse membership.

Youth Action consistently heard directly from young people through many avenues to inform our Plan. This included the COVID-19 Conversations, Outburst! and HLAC groups as well as the many consultations and surveys that the Sector assisted Youth Action to facilitate with young people.

Both young people and the Sector were clear that mental health, employment, and education should be amongst our priorities. They said they valued our work in strengthening young people and the Sector's understanding of civics

education, and government budgets and elections. Additionally, they spoke about the importance of advocating for issues impacting the Sector, as well as addressing social equity and intergenerational issues.

We have chosen Youth Justice Throughcare as our primary initiative over the lifetime of the Plan. This will allow us to focus advocacy activity on the importance of the supports and services provided by the Sector across the range of young people's interactions with the law and justice system.

Young people, youth workers, the board and staff wanted to ensure that in all our work we hold ourselves accountable. We will do this by using a rights-based lens to focus on programs, policy and advocacy that achieves meaningful outcomes, embed strengths-based approaches, and are informed by data and evidence. We will also be an ally to the self-determination of First Nations communities, be led by the expertise of young people and the



Sector, and be a trusted partner and collaborator. We have identified four key areas to achieve these outcomes: Member Services, Advocacy and Campaigns, Voice, and Sector Development.

Most importantly, in all our work and practices, we continue to strive to be inclusive of young people who are regional, First Nations, LGBTIQA+, with disability, from culturally and linguistically diverse communities, including migrants and refugees, and doing it tough.

#### Principles that underpin our work



#### Expertise and lived experience of young people

#### **Member services**

Ally to self-determination

Embedding structure for stakeholder voice to inform the ongoing work of the organisation and feedback to the government.

#### **Campaigns & advocacy**

Advocate on behalf of young people and the Sector to provide advice on systemic issues.

Campaign for systemic change that leads to better outcomes for young people from diverse cultures, backgrounds, and experiences. Give particular focus to young people who are doing it tough, including young people in contact with the child protection and justice systems, and those experiencing disadvantage.

Raise positive profile of young people in the media and their communities and promoting an understanding of young people's experiences.

#### **Voice**

Support and resource young people to be able to participate in systems that affect them.

Facilitate the increase of young people's participation in decision making and service design processes through provision of expert advice to government partners, other Peaks, NGOs, and the Sector.

Embed participatory framework within Youth Action that ensures the diversity of voices and expertise of the Sector and young people drives our advocacy work to inform government.

#### **Sector development**


Undertake research collaborations that support innovation and build evidence to build capacity within the Sector, influence commissioning activities, enhance service delivery, and improve outcomes for young people.
